STALLION SERVICE CONTRACT

The purpose of this contract for the purchase of semen from the Stallion: HANNIBAL

This Stallion is owned by Valerie Frederick and stands in Alburits, Pa. This contract is between Valerie Frederick (*Valhalla Friesian Farm*) and _____ (Mare Owner) to cover the insemination of the Mare _____ for the 2008 Breeding Season.

Breed of Mare: _____

Valerie Frederick (*Valhalla Friesian Farm*) and Mare Owner mutually agree that this contract includes the following terms and conditions:

1. Mare Owner is the legal owner/lessee of the mare and desires to purchase semen to artificially inseminate the above-mentioned mare. Use of this semen is limited to the Mare covered by this contract. A breeding certificate will be issued to cover registration of one (1) foal, unless twins are born.
2. The Breeding Fee of \$ 500.00, including the Booking Fee of \$ 95.00. Mare Owner agrees to pay the full breeding fee *before* the semen is collected and shipped.
3. In addition to the breeding fee, a Collection Fee of \$ 175.00 is charged by Valerie Frederick for each semen collection.
4. The cost of shipping and semen container are the responsibility of the Mare Owner and will be sent by FedEx. A \$300.00 deposit for semen container is required by Triad Farm Hanoverians, Inc., 405 Durham Rd., Riegelsville, PA 18077, until container is returned.
5. Mare Owner must give *Valhalla Friesian Farm* adequate notice when the Mare is coming into heat and must have taken care of the payment requirements for semen collection and shipping. At least a 72-hour collection notice must be given for prompt service. Mare Owners are served on a first-come-first-served basis; therefore it is strongly recommend Mare Owners notify *Valhalla Friesian Farm* of their anticipated breeding date.
6. *Valhalla Friesian Farm* recommend that Mare have an ultra sound between 14 and 20-days after insemination and, if pregnant, done again at 30-days to confirm pregnancy.
7. *Valhalla Friesian Farm* will make every effort to assist Mare Owner and Mare Owner's Veterinarian in getting the contract Mare pregnant. However, should the Mare fail to conceive and a completed veterinary certificate to that effect be received by us, *Valhalla Friesian Farm* will renew this contract and conditions for the next breeding season with no charges for the Breeding Fee (Semen Collection Fees and Semen Transport Fees will still

apply). *Valhalla Friesian Farm* reserves the right to require Mare Owner to substitute the Mare depending on information received from the Mare Owner and Veterinarian.

8. Should Mare fail to carry the conception to full term and delivers a foal that stands and nurses, a return privilege will be granted which must be used in the next breeding season. The Breeding Fee will be waived, but Semen Collection Fees and Semen Transport Fees will still apply. A Veterinarian Certificate must be received determining cause of death, abortion, or stillborn nature of the foal, plus a breeding soundness report that the Mare is again fit to breed. This guarantee also covers the death of the Mare prior to foaling and delivering a live foal.
9. This contract is for fresh cooled semen from Hannibal. In case of the death of above Stallion before servicing the mare or in honoring any return privileges or live foal guarantee, *Valhalla Friesian Farm* will refund all fees to mare owner.
10. Mare Owner assumes all responsibilities for the condition of their Mare and bears all risk of loss or damage to the Mare by death, disease, injury, infection or otherwise and by any cause whatsoever including inappropriate, untimely, or negligent insemination or failure of insemination. Mare Owner holds harmless Valerie Frederick (*Valhalla Friesian Farm*) its owner, employees and agents from any liability for any damages associated therewith.
11. It is the Mare Owner responsibility to contact the appropriate registries to register their foal and complete it's requirements.
12. This breeding contract is subject to interpretation under the laws of the State of Pennsylvania and any disputes must be brought in a court of lawful jurisdiction in Berks County.
